## Parking Rules and Regulations

### PARKING ON SCHOOL CAMPUS IS A PRIVILEGE, NOT AT RIGHT

Parking decals cost \$60.00 for the whole year.

1. Parking decals must be properly affixed and displayed on rearview mirror. Decals are non-transferable.
2. If you temporarily need to drive a vehicle other than your registered vehicle, it is your responsibility to notify the parking monitor for a temporary permit. Only vehicles which belong to the student's immediate household may be used as a substitute vehicle. Vehicle registration and proof of insurance must be provided upon application for a temporary permit.
3. Students will be required to park in designated lots. Vehicles parked in an unauthorized area (Staff, Visitor, Handicap, Fire Lanes, etc.) will be issued a parking violation (\$5.00 fine). Student vehicles not registered may be towed at operator's expense or issued a parking violation.
4. The speed limit in school parking lots is 5 mph. Students identified as being guilty of reckless driving practices, violating state driving rules, misconduct warranting suspension, or repeated disobedience of parking rules and regulations are subject to loss of driving privileges.
5. Students are not allowed to leave campus without the written permission from school administration.
6. Students are not allowed to go to their vehicle during the school day without permission from a dean or school administrator.
7. Decal holders who obtain new vehicles must complete a new parking application. There is no additional charge unless the decal is lost or destroyed. Replacement for lost or destroyed decals will be available at a cost of \$10.00 each.
8. No student will be permitted to drive another student's vehicle without approval from an administrator.
9. The transportation of any weapon or firearm to school is strictly prohibited. Violations can result in criminal charges.
10. All vehicles on SJTHS property are subject to search and seizure (Florida Statutes 230.22 (2) ). SJTHS and the St. Johns County School District are not responsible for any damage or losses to vehicles parked at SJTHS.
11. Decal refunds are not given.
